HONOURS AND AWARDS

House of Lords, SW1A 0PW. 13th January 1975.

The QUEEN has been pleased by Letters Patent under the Great Seal bearing date the 13th day of January 1975, to appoint the Right Honourable Walter Ian Reid Fraser (commonly called Lord Fraser), one of the Senators of the College of Justice in Scotland, to be a Lord of Appeal in Ordinary under the Appellate Jurisdiction Act, 1876, as amended by subsequent enactments, and to grant to him the dignity of a Baron for life by the style and title of BARON FRASER OF TULLYBELTON, of Bankfoot in the county of Perth.

THE EUROPEAN COMMUNITIES (DEFINITION OF TREATIES) ORDER 1973 (S.I. No. 1314)

For the purpose of entry into operation of the European Communities (Definition of Treaties) Order 1973 (S.I. No.

The Trunk Road (Abergele Road, Llanddulas) (Prescribed Routes) Order, 1975
