NEWPORT BOROUGH COUNCIL

*The Newport Borough Council (Central Area)
(Prohibition and Restriction of Waiting, Loading and
Unloading) (Amendment) Order 1975*

Notice is hereby given that on 17th January 1975, the Newport Borough Council made the above-named Order, acting on behalf of the Gwent County Council in pursuance of arrangements made under Section 101 of the Local Government Act 1972 and in exercise of the Gwent County Council's powers under Sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972.

The Order will come into operation on 8th February 1975. Its effects are that the County Borough of Newport (Central Area) (Prohibitions and Restriction of Waiting, Loading and Unloading) Order 1973 will be amended as follows:

- (a) vehicles may not wait between 8 a.m. and 6 p.m., Mondays to Saturdays, on part of the north-east side of Commercial Street between Skinner Street and Corn Street, Newport. (At present, vehicles may not wait between 8 a.m. and 9.30 a.m., 12.30 p.m. and 1.30 p.m. or 4.30 p.m. and 6 p.m., Mondays to Saturdays; and not for more than one hour in any two hours between 9.30 a.m. and 12.30 p.m. or 1.30 p.m. and 4.30 p.m., Mondays to Saturdays, on this part of road. The existing loading and unloading restrictions on this part of road will remain unaltered.);
- (b) the restriction on vehicles from waiting between 8 a.m. and 6 p.m., Mondays to Saturdays, at the former Bus Pull-In, Upper Dock Street, Newport, will be revoked;
- (c) Hackney Carriages will be exempted from the existing waiting restrictions in Austin Friars, Newport, where a temporary Hackney Carriage rank will be established.

Exceptions will be included in the Order to permit waiting for the purposes of:

- (a) picking up and setting down passengers;
- (b) loading or unloading goods (in part of the Order);
- (c) delivery or collection of postal packets;
- (d) the maintenance of the roads;
- (e) the supply of gas, water and electricity and of any telegraphic line;
- (f) the pursuance of statutory powers or duties; and
- (g) a funeral.
