*The Neath-Abergavenny Trunk Road (Aberdulais-Llandarcy)
(Prohibition of Waiting) (Clearways) (Wales) Order 1975*

Notice is hereby given that the Secretary of State for Wales intends to make an Order under Section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit (with certain exceptions) the waiting of vehicles in any part of the carriageways forming part of the length of trunk road specified in the Schedule hereto. The prohibition will not apply to stage carriages and express carriages.

The Order will also prohibit trading from the verges of the main carriageways of that length of road.

Copies of the proposed Order, together with a plan and a statement of reasons for making the Order, are available for inspection during normal office hours at the offices of the Neath Borough Council, Civic Centre, Neath.

That length of the Neath-Abergavenny Trunk Road (A465) in the County of West Glamorgan which extends from, and includes Llandarcy Interchange to and including Aberdulais Interchange, a distance of approximately 3.70 miles.

*The Trunk Road (Aberdulais-Llandarcy, West Glamorgan)
(Prohibition of Foot Passengers) Order 1975*

Notice is hereby given that the Secretary of State intends to make an Order under Section 1 of the Road Traffic Regu-

lation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit pedestrians from proceeding in that length of road specified in Schedule 1 to this Notice. The footways specified in Schedule 2 to this Notice will be excepted from the proposed Order.

Exceptions will be provided in the Order to allow pedestrians to walk on the trunk road in any of the following circumstances:

- (a) to investigate any accident which has occurred on or near the trunk road;
- (b) to avoid or prevent an accident or to obtain or give help required as the result of an accident or emergency provided as little danger or inconvenience as possible is caused to other traffic;
- (c) where it is necessary to do so as the result of a vehicle stopping due to a breakdown or other defect or the vehicle being prevented from proceeding by circumstances outside the driver's control;
- (d) to recover or move any object which has fallen on to the road;
- (e) in exercise of their duties as members of the police service, fire service or ambulance service;
- (f) to carry out maintenance to the road or services therein; or
- (g) in pursuance of statutory powers or duties.

The footway on the western side of the northbound slip road which extends from Llandarcy Interchange in a northerly direction on to the London-Fishguard Trunk Road (A48) which footway extends from its junction with the London-Fishguard Trunk Road (A48) in a general southerly direction to its junction with the Neath Abbey Station-Swansea (St. Helens Road Station) Road (B4290), a distance of approximately 219 yards.

The footway on the eastern side of the southbound slip road which extends from Llandarcy Interchange in a northerly direction on to the London-Fishguard Trunk Road (A48) which footway extends from its junction with the carriageway of the London-Fishguard Trunk Road (A48) in a general south-easterly direction to its junction with the link road leading to Pen-y-Heol.

Footway on that length of the Neath-Abergavenny Trunk Road (A465) at Aberdulais Interchange at Aberdulais in the County of West Glamorgan excluded from the provisions of the proposed Order.

The footway on the northern side of that part of the trunk road which extends from a point 138 yards north-east of Penscynor Railway Bridge in a south-easterly direction for a distance of 54 yards.

HIGHWAYS ACTS 1959 TO 1971

Newport-Shrewsbury Trunk Road (New Inn By-Pass, Pontypool) Order 1971

Newport-Shrewsbury Trunk Road (New Inn By-Pass, Pontypool Side Roads) Order 1971

Notice is hereby given that the Secretary of State for Wales has appointed T. V. Burrows, Esq., C.Eng., F.I.C.E., F.I.Mun.E., to hold a Public Local Inquiry commencing at 10.30 a.m. on Tuesday 15th April 1975 at Catholic Social Club, Conway Road, Pontypool, Gwent in connection with the above-mentioned Orders.

1. The first said Order would if made, authorise the Secretary of State:

(a) to construct new roads from Race Farm to by-pass New Inn, Pontypool in the County of Gwent, which shall become trunk roads, herein after referred to as "the new trunk roads", as from the date when the Order comes into operation, and

(b) to provide for the length of the Newport-Shrewsbury Trunk Road in the County of Gwent to be superseded by the construction of the new trunk roads, shall cease to be trunk road as from the date on which notice is given by him to the County Council of Gwent (who will become the highway authority responsible for that length) that the new trunk roads are open for through traffic.

2. The second said Order would, if made, authorise the Secretary of State:

(a) (i) to improve, raise, lower or otherwise alter highways,
(ii) to stop up highways,
(iii) to construct new highways,
(iv) to stop up private means of access,
(v) to provide new means of access, and
(vi) to close highways temporarily
all in the vicinity of the said new trunk road, and

(b) to provide for the transfer of the new highways to the County Council of Gwent as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.

Copies of the said draft Orders and the relevant plans may be inspected free of charge at all reasonable hours at the Welsh Office, Graham Building, Newport Road, Cardiff and at the Offices of Gwent County Council, County Hall, Cwmbran; Torfaen Borough Council, Council Offices, Pontypool.

The Secretary of State hereby directs pursuant to Section 14 (5) of the Highways Act 1971 that any person who intends to submit that any highway or proposed highway to which the said draft Orders relate should follow an alternative route, or that instead of improving, diverting or altering a highway to which the said draft Orders relate a new highway should be constructed on a particular route, shall send to him at the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff CF2 1YU not later than 1st April 1975 sufficient information about the alternative route or the route of the new highway, as the case may be to enable it to be identified. Failure to comply with this direction will entitle the Secretary of State and the person holding the Inquiry to disregard so much of any objection as consists of such a submission.

The Trunk Road (Glyn-Neath) (Prohibition of Waiting) (Experimental) Order 1975

Notice is hereby given that the Secretary of State for Wales has made an Order under Section 1 (6), 9 (1) and (4) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974 which shall come into operation on 3rd March 1975.

The effect of the Order is to:

- (a) suspend during the operative period of the Order the provisions of:
 - (i) The Trunk Road (Various Roads, Glyn-Neath) (Prohibition of Waiting) Order 1968, and
 - (ii) The Trunk Road (High Street, Glyn-Neath) (Prohibition of Waiting) Order 1968; and
- (b) prohibit the waiting of any vehicle at any time on the sides of road specified in the Schedules to this Notice.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition; the removal of any obstruction to traffic; the maintenance of the road or the services therein; to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

Exceptions have also been provided in the Order to allow vehicles in actual use on any of the sides of road specified in the Schedules to this Notice to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953 and to allow goods to be loaded on to or unloaded from the vehicle if that vehicle is being used in the side of road specified in Schedule 2 to this Notice.
