SOUTHAMPTON CITY COUNCIL

The City of Southampton (Queen's Terrace) (Experimental) (Bus Priority) Order 1975

Notice is hereby given that Southampton City Council made the above Order on 3rd March 1975 pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council and in exercise of the powers of the said County Council under Section 9 of the Road Traffic Regulation Act 1967.

The effect of this Order which comes into operation on 10th March 1975 will be:

1. To create with-flow bus lane:
 - (a) For eastbound buses in Briton Street from the junction of Queen's Way to the junction of Orchard Place and Queen's Terrace.
 - (b) For north-eastbound buses in Orchard Place from a point 41 metres north of the extended northern kerbline of Platform Road northwards for a distance of 35 metres.
 - (c) For north-eastbound buses in Orchard Place at the intersection of Queen's Terrace and Briton Street.
 - (d) For eastbound buses in Queen's Terrace from the junction of Orchard Place eastwards for a distance of 160 metres.
2. To introduce yellow box markings at the junction of Canute Road, Platform Road, Queen's Terrace and Terminus Terrace.
3. To prohibit waiting at any time:
 - (a) On both the north and south side of Briton Street from the junction of Queen's Way eastwards to the junction of Orchard Place.
 - (b) On the south side of Canute Road from the extended eastern kerbline of Terminus Terrace eastwards for a distance of 22 metres and from a point 63 metres east of the extended eastern kerbline of Terminus Terrace, westwards to the line of the first car parking bay.
 - (c) On both the east and west side of Latimer Street from the junction of Queen's Terrace northwards for a distance of 10 metres.

(d) On the east side of Orchard Place from the junction of Queen's Terrace northwards for a distance of 8 metres; on the south-east side of Orchard Place from the junction of Platform Road northwards to the junction of Queen's Terrace and on the north-west side of Orchard Place from the junction of Platform Road to the junction of Briton Street.

(e) On the north side of Platform Road from the junction of Terminus Terrace westwards to the junction of Orchard Place; on the south side from a point 25 metres west of the extended eastern kerbline of Terminus Road, westwards to the entrance to No. 4 Dock Gate and from No. 4 Dock Gate westwards to a point 61 metres west of the extended western kerbline of Latimer Street.

(f) For the entire length of the south side of Queen's Terrace.

(g) On the east side of Terminus Terrace from the extended northern kerbline of Canute Road northwards for a distance of 65 metres and on the west side from the junction of Queen's Terrace southwards to the junction of Platform Road.

4. To prohibit all vehicles from proceeding northwards in that part of Orchard Place (from the junction of Briton Street northwards for a distance of 5 metres).

Pedal cycles and emergency vehicles when answering emergency calls will be allowed to use the with flow bus lanes.

The Order comes into operation on the 17th March 1975 and from that date until 16th September 1976 no person shall cause a vehicle to proceed

- (a) along Highfield Road or Roseberry Road across their junction with each other

The effect of this prohibition is that

- i. Traffic proceeding in a southerly direction along Roseberry Road may not turn right into Highfield Road
 - ii. Traffic proceeding in a northerly direction along Roseberry Road may not turn right into Highfield Road
 - iii. Traffic proceeding in an easterly direction along Highfield Road may not turn left into Roseberry Road
 - iv. Traffic proceeding in a westerly direction along Highfield Road may not turn left into Roseberry Road
- (b) nor cause any vehicle to proceed in a northerly or southerly direction beyond that part of Lansdowne Road adjacent to the boundary of dwellinghouses numbers 77/75 and 74/72 Lansdowne Road.

Access to the following can be gained from Longlands Road: Bilsdale Road, Trentholme Road, Hutton Road, Lansdowne Road up to number 72 and 75, Roseberry Road up to number 85 and 86, Highfield Road from number 54 and 57 upwards, Huron Close and Ingleby Road.
