## DEPARTMENT OF THE ENVIRONMENT

### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the stopping up of lengths of Malting Villas Road and Greenways, Rochford, to enable residential development to be carried out by Rochford District Council.

The proposed Order will require the provision of new highways maintainable at the public expense, for which the highway authority is to be the Essex County Council.
