

of road known as New Corporation Road, at Cardiff, in the county of South Glamorgan, which extends from a point 360 yards east of its junction with Willow Avenue to its junction with Rover Way, a distance of 253 yards, to enable development to be carried out in accordance with planning permission granted under Part III of that Act.

The Order will require that the new length of highway to be provided as the diversion be a highway maintainable at public expense, for which the highway authority will be the South Glamorgan County Council.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order, may within 6 weeks of the 4th June 1975, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
