POST OFFICE ACT 1969, SECTION 13 (2)

Approval given on behalf of the Secretary of State for Industry on 28th May 1975

In exercise of the powers conferred by section 13 (2) of the Post Office Act 1969 and now vested in the Secretary of State by virtue of the Ministry of Posts and Telecommunications (Dissolution) Order 1974 (SI 1974 No. 691), I L. H. Quilter, an officer of the Department of Industry duly authorised in that behalf, hereby give my approval on behalf of the Secretary of State to the production or purchase (as specified hereunder) by the Post Office for supply to outside persons for outside use of things of the descriptions set out below, on condition that the sums received or receivable out below, on condition that the sums received or receivable by the Post Office for supplying such things shall not exceed £70,000 in aggregate in any year:

(1) the purchase of:

(a) prints or negatives of cinematographic films made by or for the Post Office or of extracts from such films and

(b) videotape transcripts of such films or of extracts therefrom suitable for inclusion in other cinematograph films or television programmes and

(2) the production or purchase of:

 (a) magnetic transcriptions from sound-tracks of films made by or for the Post Office
 (b) foreign language versions of such sound-tracks and (c) prints or negatives of photographs or colour trans-parencies taken by or for the Post Office which are suitable for inclusion in printed publications, slide programmes, cinematograph films, exhibitions or displays.

In this approval:

outside persons" means persons other than the Post

outside persons" means persons other than the Post Office or its subsidiaries.
"outside use" means use by outside persons otherwise than in connection with services provided by the Post Office or a subsidiary of its.
"year" means a period of twelve calendar months ending on 31st March.

This approval supersedes the approval given to the Post Office on behalf of the Minister of Posts and Telecommunications on 20th December 1972 and published in the London Gazette on 4th January 1973.

Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to a highway to which the Order relates shall be entitled to

to a highway to which the Order relates shall be entitled to be compensated by the Wyre Borough Council as the local planning authority in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable.
