ROAD TRAFFIC ACTS

BEDFORD DISTRICT COUNCIL

The Borough of Bedford (Traffic Regulation) (Waiting Restrictions) (Consolidation) Order 1968 Amendment No. 26/1975.

Notice is hereby given that the District Council of Bedford pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Local Government Act 1972 with the County Council of Bedfordshire in exercise of the powers of the said County Council under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 (which said Act of 1967 as so amended is hereinafter referred to as the "Act of 1967"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with section 84C (1) of the Act of 1967 have made an Order the effect of which will be to amend the Borough of Bedford (Traffic Regulation) (Waiting Restrictions) Consolidation Order 1968 by: Restrictions) Consolidation Order 1968 by:

- (1) Prohibiting waiting at any time on both sides of Derby Place, Bedford, along its whole length.
- (2) Prohibiting waiting at any time on both sides of Peel Street, Bedford, along its whole length.
- (3) Prohibiting waiting at any time on both sides of Princes Street, Bedford, along its whole length.
- (4) Prohibiting waiting at any time on both sides of Queen Street, Bedford—
 - (i) from Tavistock Street to a point 15 yards north of Albert Street;
- (ii) from Roff Avenue to a point 20 yards southwards. (5) Prohibiting waiting at any time on both sides of Wellington Street, Bedford, from The Broadway to a point 15 yards north of Albert Street.

The Order contains exceptions to permit waiting for the surposes of boarding or alighting, loading or unloading, building and demolition, removing obstructions, roadworks, maintenance of essential services, taking in petrol, oil, water or air from any garage.

Any person who desires to question the validity of or of any provision contained in the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of the 30th May 1975 apply to the High Court for this purpose.
