

and to ensure that special regard is paid to these qualities when proposals for development are considered.

The main provisions of the 1974 Act are that with certain exceptions, no buildings within Conservation Areas, listed or unlisted, may be demolished without the consent of the District Council and that owners wishing to fell or lop a tree must give notice to the District Council who then have 6 weeks to decide whether a Tree Preservation Order should be served.

Copies of the maps of the Conservation Areas can be inspected during normal office hours, Monday to Friday, at the East Cambridgeshire District Council Offices, Park Lane, Newmarket; at the Fenland District Council Offices, County Hall, March; and at the County Planning Department, Shire Hall, Cambridge.

SCHEDULE

East Cambridge District

Chippenham

The Conservation Area includes all the buildings in High Street and those in New Street as far as nos. 45 and 46. The Vicarage, Parish Church and entrance gates to Chippenham Park are also included.

Dullingham

The Conservation Area includes property on both sides of Station Road from its junction with Brinkley Road as far as The Crescent plus the Vicarage and a small length of Eagle Lane. In the eastern part of the Area, Church Lane, Church Close, the Parish Church, the Boot Inn and buildings on the north side of Stetchworth Road as far as Clare Farm are also included.

Isleham

The Conservation Area covers the central core of the village, including all of Church Street and Church Lane; Sun Street as far as nos. 26 and 27; The Causeway as far as Lady Peytons Hospital; Pound Lane as far as no. 35; West Street as far as the Red Lion public house; Mill Street as far as and including the Recreation Ground and The Pits; and Malting Lane to include Grain House and the school.

Reach

The Conservation Area covers the core of the village including buildings fronting on to the Hythe, Fair Green, High Street and north-west side of Upware Road. Also included are Chapel Farm, Fitzroy Farm and Fullers Farm buildings.

Wicken

The Conservation Area covers the centre of the village and buildings fronting on to High Street, Pond Green, Butts Lane (excluding nos. 12, 18 and 20) and Cross Green. In addition, the western end of Church Road is included (nos. 55 and 57) as are nos. 1 to 7 Chapel Lane and nos. 2 and 4 in North Street.

Fenland District

Chatteris

The Conservation Area covers the Town Centre and includes the following properties—High Street nos. 1 to 23 (odd) and nos. 2 to 26 (even); all Market Hill; all East Park Street; Church Lane, north and east sides including Parish Church and Vicarage and no. 16; St. Martins Road, nos. 1, 9, 10, 12 and 14; Wenny Road nos. 1 to 9 and 2 to 10; Wood Street nos. 1 and 2; South Park Street nos. 1 to 5 and 2 to 6 plus 24, 25 and 27; Victoria Street nos. 1, 2 and 4; all of Park Street except nos. 9, 11 and 13; west side of Station Road; all of West Park Street as far as Wood Street except the west side from nos. 6 to 22.

(Vyners School) Public Path Stopping Up Order 1975

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order" made on the 19th May 1975 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the London Borough of Hillingdon as an unopposed Order.

The effect of the Order, if confirmed without modification will be to extinguish the public right of way running

from Western Avenue to Warren Road around the south-eastern boundary of Vyners School and create an alternative highway in lieu.

A copy of the Order and the map contained in it has been placed on deposit at the Council Offices, Belmont House, 38 Market Square, Uxbridge and may be inspected free of charge at the Planning Department, Reception Desk on the fourth floor between the hours of 10 a.m. and 4 p.m. Monday to Friday and at Ickenham Library, Long Lane, Ickenham, between the hours of 9.30 a.m. to 8 p.m. Monday to Friday and 9.30 a.m. to 5 p.m. on Saturday.

Any representations or objections with respect to the Order may be sent in writing to The London Borough of Hillingdon, Council Offices, Belmont House, 38 Market Square, Uxbridge, Middlesex, UB8 1TU, quoting the reference B.Sol/DC/T10/75/5 not later than 3rd July 1975 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the London Borough of Hillingdon, may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary for Confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

If you wish to be notified if the Order is confirmed, and to have a copy of the Order as confirmed, you should write to the council giving your name and the address to which the documents should be sent.

WAKEFIELD CITY COUNCIL

TOWN AND COUNTRY AMENITIES ACT, 1974

Conservation Area at Normanton

Notice is hereby given that the Council of the City of Wakefield as District Planning Authority, after consultation with the West Yorkshire Metropolitan County Council, have designated the area referred to in the Schedule to this notice as a Conservation Area for the purposes of section 1 of the Town and Country Amenities Act, 1974. The designated area, which the District Council consider to be an area of special architectural or historic interest the character or appearance of which should be preserved or enhanced, will be the subject of stringent control of development and the District Council intend to take such action as may be available to them to secure the preservation and general improvement of the area. In particular, controls are applied to the demolition of buildings (owners are required to apply to the Council for listed building consent before carrying out works of demolition to any building or part of a building within the area) and to the felling, topping and lopping of trees within the area. Control may also be imposed in respect of the display of advertisements. There are penalties in the event of violation of this control.

The Conservation Area is more particularly defined on the map, which may be inspected, free of charge, during normal office hours at the office of the Chief Planning Officer of the District Council, Newton Bar, Wakefield, or at the office of the Secretary to the District Council, Town Hall, Wakefield.

THE SCHEDULE

The Conservation Area is centred around All Saints Church and the southern end of Normanton High Street.

The boundary of the Conservation Area includes the Old Churchyard area of All Saints Church, passes along the southern boundary of No. 144 High Street, crosses the High Street and passes along the back edges of properties Nos. 1-11 Snyderdale Road. From here the boundary follows the rear edge of the properties fronting the High Street, as far as the Castleford Road, where it includes the old market cross. It then passes down the High Street as far as Princess Street, where it includes Manor Crest and the adjoining house known as Manor Farm. The boundary returns behind these properties to the High Street, and runs along this until it reaches Normanton C. of E. School. It then runs along the back of the school and vicarage to the churchyard.
