BUCKINGHAMSHIRE COUNTY COUNCIL

The Buckinghamshire County Council (Prohibition and Restriction of Waiting) (Olney) Order, 1975

Notice is hereby given that Buckinghamshire County Council propose to make an Order under sections 1 (1), (2), (3) and 84 (1) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, and Schedule 19 to the Local Government Act, 1972, the effect of which will be to prohibit waiting at any time in the lengths of road specified in Schedule 1 to this notice; and

B

to introduce a restriction of 1 hour during the hours of 8 a.m. and 6 p.m. on any day other than a Sunday with return within one hour prohibited, in any of the lengths of road as specified in Schedule 2 to this notice.

Exemptions will be provided in the Order to enable a vehicle to wait in the lengths of road specified in Schedule 1 for so long as may be necessary to enable a person to board or alight from a vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable a vehicle if it cannot conveniently be used for such a purpose in any other road to be used in any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road or of any services therein. An exemption will be provided to enable disabled persons' vehicles to wait in any length of road specified in Schedule 1 and Schedule 2 to this notice.

A copy of the proposed Order and a map indicating the length of road affected together with a statement of reasons for proposing to make the Order may be inspected during normal office hours at the County Hall, Aylesbury, and at the offices of the Milton Keynes Borough Council, Sherwood House, Sherwood Drive, Bletchley.
