*The M4 Motorway (Tredegar Park-St. Mellons Section)
and Connecting Roads (Side Roads No. 3) Order 1975*

The Secretary of State for Wales hereby gives notice that in relation to the M4 Motorway which he proposes to construct at Castleton in the County of Gwent in pursuance of "The M4 Motorway (Tredegar Park-St. Mellons Section) and Connecting Roads Scheme 1973" he has made an Order under Section 13 of the Highways Act 1959 the effect of which is—

- (a) to authorise him—
 - (i) to stop up parts of footpaths; and
 - (ii) to construct new highways which will be footpaths all on or in the vicinity of New Park Farm, Castleton; and
- (b) to provide for the transfer of the said new highways to the County Council of Gwent as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.

Bolton Metropolitan Borough No. 3 (Bolton Borough No. 49) Smoke Control Order 1975

The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

HASTINGS BOROUGH COUNCIL
