SCHEDULE

23. *Gratuities for Third Officers, WRNS, retired compulsorily after 7 years' service.* Third Officers, WRNS, who are retired compulsorily for non-employment on completion of 7 years' service in the rank on or after 31st March 1972, will be eligible for a gratuity of £1922.

24. *Gratuities for Officers on short service engagements.* WRNS Officers granted short service commissions and who satisfactorily complete a 7-year commission on or after 31st March 1972, will be eligible for a gratuity of £1922. On optional withdrawal after satisfactorily completing 5 years' service on a short service commission, they will be eligible for a gratuity of £1373.

26. *Gratuities for permanent and short service Officers leaving on marriage or for compassionate reasons:*

(a) Permanent Officers who have completed at least 4 years' service as Officers and who, being ineligible for retired pay or for gratuities under the provisions of the foregoing Clauses, are permitted to retire or are required to terminate their service on marriage or for compassionate reasons where the Secretary of State for Defence is satisfied that such reasons necessitate retirement or termination of service on or after 1st April 1972, may be awarded a gratuity of £182 for each complete year of qualifying service subject to a maximum of £1823.
