Berkeley Road, Burlington Road, Burton Road, Cromwell Road, Fitzhugh Place, Harborough Road, Milton Road, Sandhurst Road, Wilton Avenue and Wilton Road.

The reasons for making this Order are to control the volume of vehicular parking in roads with a limited capacity and to remove commuter parking in residential streets.

This Order also introduces parking facilities for residents and visitors in the following roads:

Berkeley Road, Burlington Road, Burton Road, Carlton Road, Cromwell Road, Devonshire Road, Fitzhugh Place, Handel Road, Harborough Road, Holt Road, Milton Road, Morris Road, Newcombe Road, Sandhurst Road, The Polygon and Wilton Avenue.

In addition, disabled person's vehicles will be permitted to wait for up to two hours, return prohibited within one hour, where only waiting restrictions and not a lane restriction or loading/unloading restrictions apply. Entry into a bus lane will be allowed to obtain entrance to off-street loading or garaging premises.

The City of Manchester Traffic Regulation Order (No. 4) 1963 will be revoked in so far as it is inconsistent with the above proposals.
