If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from the 19th June 1975 apply to the High Court for this purpose.

HALTON BOROUGH COUNCIL

The Halton Borough Council (Holt Lane and Link Road from Holt Lane to East Lane, Halton, Runcorn) (Weight Restriction) Order 1975.
