WEST SUSSEX COUNTY COUNCIL

The County Council of West Sussex (Chichester: Guildhall Street (Part) and Priory Road (Part)) (Prohibition and Restriction of Waiting) Order 1975.

Notice is hereby given that the West Sussex County Council propose to make an Order under the provisions of section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, the effect of which will be:

- (a) to alter the waiting restrictions in that length of Guildhall Street, in Chichester, which extends from its junction with Priory Lane, westwards for a distance of 14 yards (13 metres), from limited waiting (1 hour in any 2 hours between 8.30 a.m. and 6 p.m. Mondays to Saturdays inclusive) to a prohibition of waiting at and time;
- (b) to alter the waiting restrictions in that length of Priory Road, in Chichester, which extends from a point 50 yards (45.75 metres) south of its junction with Guildhall Street, south-eastwards to its junction with St. Peters, from a prohibition of waiting between 8.30 a.m. and 6 p.m., Mondays to Saturdays inclusive, to a prohibition of waiting at any time.

Exceptions will be provided in the Order to enable vehicles to stop and pick up and set down passengers, goods or merchandise, to wait when engaged in building operations or the repair of the roads or the services therein, and in connection with funerals. The restrictions will not apply to invalid carriages, and disabled persons' vehicles displaying in the relevant position disabled persons' badges issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975.

NORTH TYNESIDE METROPOLITAN BOROUGH COUNCIL

(Grand Parade, Tynemouth) (Restriction of Waiting) Order, 1975

Notice is hereby given that on the 19th June 1975 the North Tyneside Metropolitan Borough Council made the above-named Order pursuant to arrangements made under section 101 of the Local Government Act, 1972 with the County Council of Tyne and Wear, under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Road Transport Act, 1968 and Schedule 19 to the Local Government Act, 1972.

This Order which makes it unlawful to park a vehicle at any time on the west side of Grand Parade from its junction with Parkside to a point 85 feet north of that junction will come into operation on the 4th July 1975.

The usual exemptions will apply.

they may be examined between 8.30 a.m. and 4.30 p.m. Mondays to Fridays.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not made pursuant to arrangements made under section 101 of the Local Government Act, 1972 with the County Council of Tyne and Wear under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968 and Schedule 19 to the Local Government Act, 1972 or on the grounds that any requirement of these Acts or of any instrument made under them has not been complied with in relation to the Order you may within six weeks from the 19th June 1975 apply to the High Court for this purpose.

The Borough of Weymouth and Portland (Traffic Regulation) (No. 31) Order 1975
