#### NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

#### TOWN AND COUNTRY PLANNING ACT 1971, SECTION 210

*Amber Valley District Council (Footpaths Nos. 44, 46, 51 Parish of Denby) Public Path Temporary Diversion Order 1975.*

Notice is hereby given that on the 4th June 1975, the Amber Valley District Council confirmed the above-named Order.

The effect of the Order as confirmed is to close temporarily:

- that part of Footpath 44 Denby for an approximate distance of 900 feet in a south-easterly direction from its junction with Footpath 35 Denby;
- that part of Footpath 46 Denby for an approximate distance of 560 feet in an easterly direction from its junction with Footpath 35 Denby;
- that part of Footpath 51 Denby for an approximate distance of 500 feet in a north-easterly direction from its junction with Footpath 44 Denby to its junction with Footpath 53 Denby.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the Town Hall, Ripley, between 9 a.m. and 12 noon and 2 p.m. and 4 p.m. on Mondays to Fridays.

This Order becomes operative as from the date of confirmation, i.e. 4th June 1974, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may, under section 244 of the Town and Country Planning Act 1971, within 6 weeks from 19th June 1975, make application for the purpose to the High Court.

*Amber Valley District Council (Footpath No. 45 Ripley) Public Path Diversion Order 1975*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 12th June 1975, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Amber Valley District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert 300 feet of the public right of way running from Maple Avenue, Ripley in south-westerly and south-easterly directions to Highfield Way, Ripley.

A copy of the Order and the map contained in it has been deposited at the Town Hall, Ripley and may be inspected free of charge between the hours of 9 a.m. and 12 noon and 2 p.m. to 4 p.m. on weekdays.

If no representations or objections are duly made, or if any so made are withdrawn the Amber Valley District Council may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

### BERWICK-UPON-TWEED BOROUGH COUNCIL

#### BERWICK-UPON-TWEED BOROUGH COUNCIL

*The Borough of Berwick-upon-Tweed (Footpath No. 6 Parish of North Sunderland) Public Path Stopping-up Order 1975*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 12th June 1975 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Berwick-upon-Tweed Borough Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to stop up part of the public right of way running from the B1340 Seahouses-Beadnell road towards North Sunderland Point for a length of approximately 380 metres and create an alternative highway in lieu along a more northerly line approximately 300 metres in length.
