NOTICE OF APPLICATION FOR LICENCE TO
ABSTRACT WATER

Notice is hereby given that the Thames Water Authority have prepared a draft licence authorising them to abstract 17,500,000 cubic metres of water per year from underground strata in the Lower Lee between Waltham Abbey and the Lea Bridge Works of the Metropolitan Water Division of the Authority at the following points of abstraction:

(New Boreholes)

- (1) At King George's Pumping Station, Enfield Lock (TQ 373978).
- (2) At Sewardstone Road, Waltham Abbey (TQ 376963).
- (3) At Chingford South Pumping Station, Lea Valley Road, Chingford (TQ 373948).
- (4) At Flanders Weir, Chingford (TQ 367932).
- (5) At Greaves Pumping Station, Walthamstow Avenue, Chingford (TQ 362918).
- (6) At Lockwood Reservoir, Blackhorse Lane, Walthamstow (TQ 355904).
- (7) At Warwick Reservoir West, Walthamstow (TQ 348878).

The Thames Water Authority have prepared a draft Order under section 1 of the Water Resources Act 1971 authorising them to inject water into the underground strata in the Lower Lee as part of a proposed scheme for augmenting the water resources of the Lee Catchment. The abstraction to which this draft licence refers forms part of the same scheme. The Authority are making a complementary application for a new licence authorising them to abstract increased quantities of water from six of their existing well stations which are included in the proposed scheme.

The Thames Water Authority's draft Order also authorises them to discharge water abstracted under the authority of this draft licence into the River Lee Diversion for abstraction by the Authority under their existing licences.

The draft Order, the draft licence to which this notice refers and the application by the Authority for a new licence for six of their wells together form the authorities which are being sought for the carrying out of the proposed scheme of artificial recharge of the groundwater in the Lower Lee.

A copy of the draft licence and of the plans deposited with it may be inspected free of charge at the office of the Solicitor to the Authority at Brettenham House (Third Floor), Lancaster Place, London, WC2E 7EN, and at the office of the Divisional Manager, Lea Division, "The Grange", Crossbrook Street, Waltham Cross, Hertfordshire, EN8 8LX, at all reasonable hours during the period beginning 20th June 1975 and ending on 18th July 1975.

Any person wishing to make representations about the draft licence should do so in writing to the Solicitor to the Authority at Brettenham House, Lancaster Place, London, WC2E 7EN, before the end of the said period.

After the expiry of the said period the Authority will be entitled to pass a resolution by virtue of which a licence authorising the proposals shall be deemed to be granted unless the Secretary of State for the Environment either in consequence of any representations made with respect to the proposals or otherwise, requires an application for a licence to be made to him.
