3. The effect of the City of Westminster (Parking Places) (Revocation No.) Order, 197 , would be to revoke the designation by the City of Westminster (Parking Places) (No. 2) Order, 1968 of the metered parking places numbered 7 and 108 therein.

4. The restrictions imposed by the City of Westminster (Waiting and Loading Restriction) Order 1972 would apply to the areas of Belgrave Road previously designated as parking places as it applies in the immediate vicinity.

5. The above prohibitions currently have effect by virtue of a Police Experimental Scheme.
