### INLAND REVENUE

STAMP DUTIES

Whereas Section 12 (2) of the Finance Act 1899 provides that Her Majesty's Commissioners of Inland Revenue may substitute, as respects any foreign or colonial currency mentioned in the Schedule to that Act, any rate of exchange for that specified in the Schedule and may add to the Schedule the rate of exchange for any foreign or colonial currency not mentioned therein, and that such Act shall be construed as if any rate of exchange for the time being substituted or added were contained in the said Schedule, and in the case of the substitution of the rate of exchange as if the rate for which the new rate is substituted were omitted from that Schedule; and whereas by notices duly advertised pursuant to the said section the said Commissioners have from time to time, and lastly by notice duly advertised in the month of December 1974, substituted certain rates of exchange for those contained in the Schedule, and have added thereto certain rates of exchange. Now therefore the said Commissioners do hereby give notice that they substitute the following rates of exchange, based mainly on market rates which have been rounded, for those contained in the Schedule to the Finance Act 1899 as varied by the above-mentioned notices:

### BLABY DISTRICT COUNCIL

#### CLEAN AIR ACT 1956

#### *The Blaby District Council (Braunstone and Leicester Forest East) Smoke Control Order (No. 9) 1975*

Notice is hereby given that the Blaby District Council in exercise of the powers conferred on them by Section II of the Clean Air Act 1956 on the 10th June 1975 made an Order entitled "The Blaby District Council (Braunstone and Leicester Forest East) Smoke Control Order (No. 9) 1975), declaring the area described in the schedule hereto to be a smoke control area which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the exemptions provided by the Order and by virtue of Section II(4) of the Act if on any day after the Order has come into operation smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st November 1976 or before a later date determined by the Secretary of State for the Environment.

Copies of the Order and of the map referred to therein may be inspected free of charge at the Council Offices, Narborough, at all reasonable times during the period of six weeks from the 23rd June 1975.

*The Greater Manchester County (Bank Street and Manor Street, Bolton) (Prohibition of Waiting) (County) Order 1975*

The County Borough of Bolton (Traffic Regulation) (No. 1) Order 1971 will be revoked and the County Borough of Bolton (Waiting Restrictions) (Consolidation) Order 1970 will be revoked where it is inconsistent with the above proposals. The existing Prohibition of Waiting Restrictions on Manor Street and Bank Street will remain in force.

#### TYNE AND WEAR COUNTY COUNCIL

The provisions of Article 3 and of paragraph (b) of the First Schedule to the Tyne and Wear County Council (Monument, Newcastle upon Tyne) Temporary Traffic Regulation (No. 1) Order 1974 insofar as they relate to Blakett Street, Newcastle upon Tyne are hereby revoked.
