- (a) On the west side only from its junction with Mill End Close to a point adjacent to the southern boundary of
- No. 17; (b) On all sides of the island at its junction with Mill End Close on which is situated the Unicorn Public House;
- (c) On its western side only from a point adjacent the northern boundary of No. 1 to a point adjacent the northern boundary of No. 7 High Street, Cherry Hinton.

The Order contains provision permitting vehicles to wait for the purposes of:

- (a) picking up and setting down passengers;
- (b) loading or unloading goods;
 (c) the collection and delivery of postal packets;
 (d) the maintenance of roads;
- (e) the supply of gas, water and electricity and the tele-phone and telegraph services.

Provision is also made permitting disabled persons vehicles to wait in the affected lengths of road, subject to the requirements of the appropriate Regulations for a maximum period of 2 hours.

A copy of the draft Order and the plan showing the street affected and the Council's statement of reasons for making the draft Order, may be inspected at my office during normal working hours.

Objections to the proposed Order must be sent to me in writing not later than the 21st July 1975 and must specify the grounds of objection to the proposed Order.
