Controlled Parking Zone—Provision of Manually Operated Parking Meters

Notice is hereby given that the Greater London Council on 16th June 1975 made the Greenwich (Parking Places) (Amendment No. 1) Order 1975 under sections 36 and 84D of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968, and by virtue of the provisions of section 9 (1) (b) of the Greater London Council (General Powers) Act 1974.

2. The general effect of the Order will be to enable manual type parking metres (i.e., a parking meter the mechanism of which is put into operation by the insertion of a coin in the appropriate slot in the meter and by the manipulation of the handle thereon) to be used in metered parking places designated by the Greenwich (Parking Places) Order 1968 or by the Greenwich (Parking Places) (Amendment) Order 1970.

3. A copy of the Order, which will come into operation on 27th June 1975 and of the Orders specified in paragraph 2 above (and of the Orders which have previously amended the Order of 1968) can be inspected during normal office hours on Mondays to Fridays inclusive until the end of six

weeks from the date on which this notice is published in Room B.21, The County Hall, London, SE1 7PB.

4. Copies of the Order may be purchased from the Information Centre, Greater London Council, The County Hall, London, SE1 7PB.

5. Any person desiring to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant sections of the Road Traffic Regulation Act 1967 or of sections 9 to 11 of the Greater London Council (General Powers) Act 1974 or on the ground that any requirement of those sections of those Acts or of section 84A, 84B or 84C (1) of the Act of 1967 has not been complied with in relation to the Order may, within six weeks of the date on which this notice is published, make application for the purpose to the High Court.
