WEST GLAMORGAN COUNTY COUNCIL

West Glamorgan County Council (Gower Road-Killay) Shopping Precinct) (Street Parking Places) Order 1975

Notice is hereby given that the West Glamorgan County Council propose to make an Order under sections 28 and 31 of the Road Traffic Regulation Act, 1967, as amended by Part IX of The Transport Act, 1968 and Schedule 19 to The Local Government Act, 1972, the effect of which will be to make the layby fronting the Killay Shopping Precinct in Gower Road, Killay a Street Parking Place.

West Glamorgan County Council (Dwr-y-Felin Road, Neath) (Revocation and Prohibition of Waiting) Order, 1975

Notice is hereby given that the Council of the County of West Glamorgan propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, and Schedule 19 to the Local Government Act 1972, the effect of which will be to:

- (a) revoke the Order made by the Neath Borough Council in 1971 relating to waiting restrictions on the south-west side of Dwr-y-Felin Road; and
- (b) prohibit waiting between 8 a.m. and 11 p.m. on Monday to Saturday inclusive on both sides of Dwr-y-Felin Road, from the junction with Neath Abbey Road to the southern side of the railway underbridge, a distance of approximately 328 metres.

WEST GLAMORGAN COUNTY COUNCIL

West Glamorgan County Council (Commercial Street and Martyns Avenue, Seven Sisters) (Traffic Regulation) Order, 1975.

Notice is hereby given that the West Glamorgan County Council in exercise of their powers under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, and Schedule 19 to the Local Government Act 1972, propose to make an Order the effect of which will be as follows:

- (1) *Commercial Street*
 - (a) Revocation of existing One Way Traffic Order and the introduction of a new Order making the street one way in the opposite direction to prevent traffic from entering Commercial Street from High Street.
 - (b) The prevention of vehicles entering Commercial Street at the junction with Church Road, unless requiring access to premises in or abutting the street.
- (2) *Martyns Avenue*
 - (a) The making of one way traffic on both legs of Martyns Avenue abutting on to Route A.4109, to prevent vehicles entering from Church Road.
 - (b) The introduction of a 3-ton Unladen Weight Restriction except for access, at the junction with Commercial Street.
