The Bexley (Prescribed Routes) (No.) Traffic Order 197 Notice is hereby given that the Greater London Council propose to make the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The effect of the Order would be:

- (a) to prohibit vehicles from entering that area of carriage way at or adjacent to the junctions of Merlin Road, Dansington Road and Fairwater Avenue, which is shown hatched black on the plan comprising the Schedule to this notice;
- (b) to prohibit vehicles the overall width of which together with the load (if any) carried thereon exceeds 7 feet from entering that length of Danson Lane which lies between a point 50 feet south-west of the south-western kerb-line of Danson Crescent and a point 60 feet southwest of that kerb-line.

3. Exemption from the prohibition referred to in paragraph 2(b) above would be provided in the Order in respect of vehicles being used for police, fire brigade or ambulance purposes in certain circumstances.


