### CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT 1952 To: JACKIE McCLELLAND WATTS.

322 OMS/APO 09057, USAF, Germany.

Date 10th July 1975.

Pursuant to section 275 (5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely:

5 bottles of Still Table Wine, 200 King Edward Cigarillos, 200 King Edward Imperial Cigars,

imported at Dover on the 8th November 1974, have been seized as liable to forfeiture upon the grounds that the said goods being goods obtained outside the United Kingdom by a person entering the United Kingdom and being chargeable with duty and tax in respect of which the importer was not entitled to exemption from payment were required to be declared at such place and in such manner as the Commissioners have directed but they were not so declared.

Whereby and by force of section 6 (3) of the Finance Act 1968, the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a Solicitor in England who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to

be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
