COAST PROTECTION ACT 1949**

The Council of the Borough of Great Yarmouth in their capacity as Coast Protection Authority, hereby give notice under Sub-section (1) of Section 5 of the above Act that they propose to carry out Coast Protection work as described hereunder at Caister-on-Sea, in the Borough aforesaid.

The work will consist of the re-construction of approximately 100 metres of sea wall and spray apron, including the provision of steel toe piling to the base of the wall, together with the construction of one in number, groyne, 70 metres long. This groyne will be of timber and steel sheet piling construction to the whole of its length.

The estimated cost for the whole of these works which are situated North of Second Avenue, Caister is £133,000.

**GREATER MANCHESTER COUNTY COUNCIL**

*Greater Manchester County (Various Roads, Manchester)  
(Prohibition and Restriction of Waiting) (County) Order  
1975*

Notice is hereby given that the Greater Manchester County Council propose to make an Order under Section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be:

- (a) to prohibit waiting at all times on Fairfield Street from London Road to Pin Mill Brow;
- (b) to prohibit loading/unloading between the hours of 8 a.m. and 9.30 a.m. Monday to Saturday and between the hours of 4.30 p.m. and 6 p.m. Monday to Friday on Fairfield Street from London Road to Travis Street;

(c) to prohibit loading/unloading between the hours of 7.30 a.m. and 9.30 a.m. Monday to Saturday and between the hours of 4 p.m. and 6 p.m. Monday to Friday on Fairfield Street from Travis Street to Chancery Lane/Pin Mill Brow;

(d) to prohibit waiting between the hours of 8 a.m. and 6 p.m. Monday to Friday and between the hours of 8 a.m. and 12.30 p.m. on Saturday on the following lengths of road:

- (1) Blakett Street, north west side from Raven Street to Pin Mill Brow;
- (2) Indigo Street, both sides from Blakett Street to its cul-de-sac end;
- (3) Mayo Street, both sides from Fairfield Street to Blakett Street;
- (4) Temperance Street, both sides from Fairfield Street to a point approximately 45.7 metres in a south easterly direction.

The proposed Order contains exemptions to permit waiting for the purposes of boarding or alighting, loading or unloading (except when prohibited on Fairfield Street), the removal of furniture, funerals, building operations or work on or under the lengths of road. Disabled persons vehicles displaying the relevant disabled person's badge will be allowed to wait for up to 2 hours, return prohibited within 1 hour, except when a loading/unloading ban is in operation.

The following Orders will be amended where they are inconsistent with the above proposals:

The City of Manchester Traffic Regulation Order (No. 5) 1962;

The Parking Places and Controlled Parking Zone (Manchester) Order 1971.

(5) Both sides of Commercial Road as far as the Half Crown Hotel on one side including the Graveyard, and to Stonebow Road on the other side including the car park and bus station area. (6) In Daws Road 2-20 even numbers and 5-9 odd numbers are included together with Belle Vue Terrace and the properties on the east side of St. Owen Gate. (7) Number 95 Hinton Road with its curtilage extending across the river to include a width of 180 ft. on the opposite bank.

#### *Area No. 1/4/A*

##### *Broomy Hill*

This conservation area covers the early suburb of Broomy Hill and the riverside setting of the Waterworks. The boundary extends from Longmeadow, Breinton Road in the north-west, east along Breinton Road and the field boundary north of the waterworks to the centre of the old railway line at Barton Road bridge surrounding Numbers 21-84, Broomy Hill inclusive with the St. Nicholas Institute and 5 Breinton Road.
