TOWN AND COUNTRY PLANNING ACT 1971

The Secretary for State for Wales hereby gives notice that he has made an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of that length of highway described in the Schedule below to enable development to be carried out in accordance with planning permission granted by the Borough of Wrexham Maelor under Part III of that Act.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 16th October 1975 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
