## State Intelligence

PRIVY COUNCIL OFFICE

At the Court at Balmoral, the 17th day of September 1975

PRESENT,

THE QUEEN'S Most Excellent Majesty in Council

Whereas by section 3 of the Naval and Marine Pay and Pensions Act 1865 (1865 c. 73) it is enacted that all pay, wages, pensions, bounty money, grants or other allowances in the nature thereof, payable in respect of services in Her Majesty's naval or marine force to a person being or having been an Officer, seaman or marine, or to the widow or any relative of a deceased Officer, seaman or marine, shall be paid in such manner and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

And whereas Her Majesty deems it expedient to amend the Order in Council dated 25th September 1964, as amended (Orders of 22nd December 1964, 24th February 1966, 9th June 1966, 28th July 1966, 23rd August 1967, 14th February 1968, 26th July 1968, 31st July 1969, 4th February 1970, 28th July 1971, 26th July 1972, 27th July 1973, 28th June 1974 and 18th March 1975) concerning pensions and other grants in respect of disablement or death due to service in the naval forces during the 1914 World War and after 2nd September 1939 (hereinafter referred to as "the 1964 Order"):

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered that, notwithstanding anything in the 1964 Order, the following provisions of this Order shall take effect accordingly and, except in the cases stated in the Order in Council of 19th December 1881, and except as otherwise provided by statute, shall be established and obeyed as the sole authority in the matters herein treated of.

### *Substitution of Schedules to the 1964 Order*

1. For Schedules 2, 3, 4, 6 and 7 to the 1964 Order (rates of pensions and other grants payable in respect of disablement or death due to service in the naval forces during the 1914 World War and after 2nd September 1939) there shall be substituted the Schedules set out in the Appendix hereto and numbered 2, 3, 4, 6 and 7 respectively.

### *Amendment of Article 68 of the 1964 Order*

2. In paragraph (1) of Article 68 (power to dispense with probate) of the 1964 Order for the sum "£500" there shall be substituted the sum "£1,500".

### *Commencement*

3. This Order shall come into operation on 17th November 1975 so, however, that in relation to any award payable weekly the foregoing reference to 17th November 1975, where this is not the normal weekly pay day for that award, shall be construed as a reference to the first normal weekly pay day for that award following 17th November 1975.
