And there being no opposition on behalf of Her Majesty to the relief sought by the said petition as appears from the said affidavit of John Charles Longdon and the exhibit thereto

And the petitioners by their Counsel undertaking within one month of the restoration of the name of the company to the register of companies to forward to the Registrar of Companies as required by sections 124 and 126 of the above-mentioned Act, a copy of the annual return of the company for the year 1974 together with the documents annexed thereto as required by section 127 of the said Act to give to the Registrar of Companies as required by section 107 of the said Act notice of the situation of the registered office of the company at the date of incorporation and of any change therein since that date and to send to the Registrar of Companies as required by section 200 of the said Act a return containing the particulars specified in the register of directors and secretaries of the Company and a notification of any change among the directors of the Company or in its secretary or in any of the particulars contained in its said register, specifying the date of the change

This Court doth order that the name of the above-named C. A. Webber (Transport) Limited be restored to the register of companies

And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the above-mentioned Act the said C. A. Webber (Transport) Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the Registrar of Companies do advertise this order in his official name in the *London Gazette*

And it is ordered that the petitioners the said C. A. Webber (Transport) Limited and Sidney Feldman and Hannah Frances Feldman do pay the Registrar of Companies his costs of the said petition such costs to be taxed on the Common Fund basis
