NORLET LIMITED (DISSOLVED) NOTICE OF DISCLAIMER

UNDER SECTION 355 OF THE COMPANIES ACT 1948 Whereas:

(1) Pursuant to section 353 of the Companies Act 1948 Norlet Limited (hereinafter called "the Company") became dissolved on the 26th November 1968.

(2) It is alleged that immediately before such dissolution the property disclaimed by this notice was vested in the Company and may by virtue of section 354 of the Com-panics Act 1948 be deemed to have become bona vacantia and to have vested in the Crown.

The Trunk Road (Builth Wells, Powys) (Prohibition and Restriction of Waiting) Order 1975

Notice is hereby given that the Secretary of State for Wales intends to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968. The effect of this Order will be to prohibit waiting in the lengths of road and on the sides of road specified in Schedule 1 to this notice; and restrict waiting on the sides of road specified in Schedule 2 to this notice, to 30 minutes in any hour between 8 a.m. and 6 p.m. on any day other than a Sunday.

Exceptions will be provided in the Order to enable a vchicle to wait for so long as may be necessary for a person to board or alight from the vthicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building, industrial or demolition operation, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local or water authority in pursuance of statutory powers or duties. statutory powers or duties.

Exceptions will also be provided in the Order to allow vehicles bearing both a disabled person's badge and a parking disc to wait in the lengths of road or on any of the sides of road specified in Schedule 1, for a period not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road or on the same side of road).
