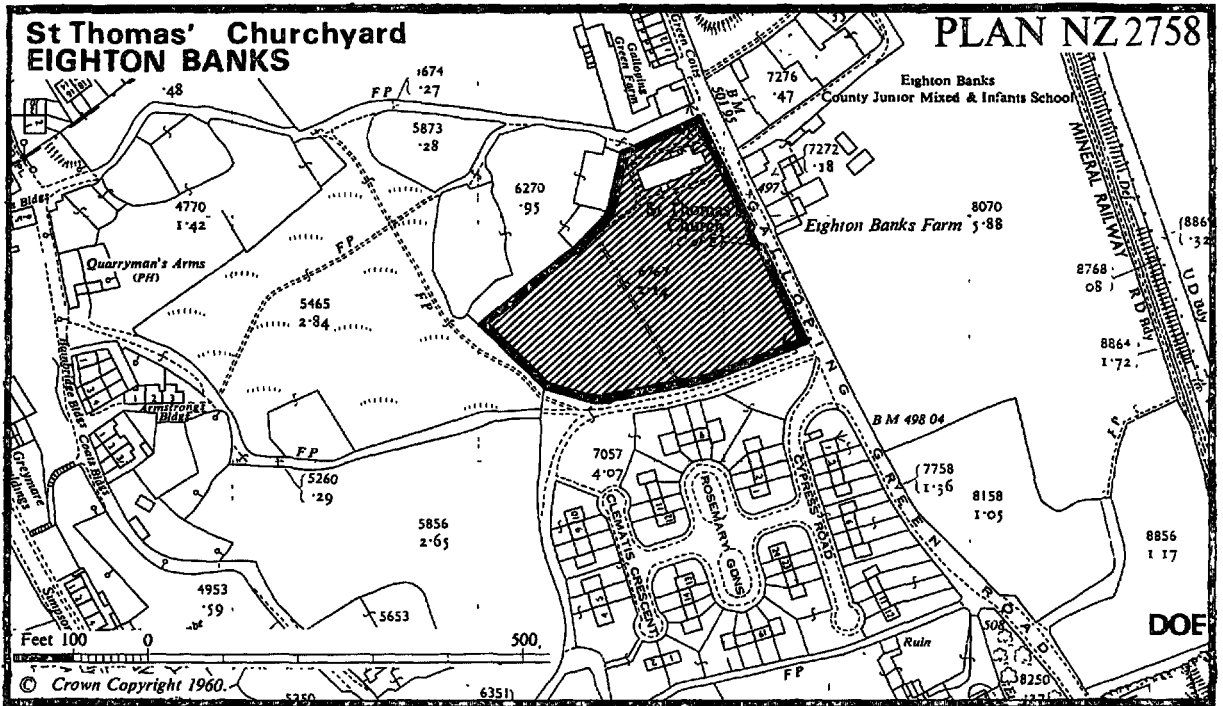


The Plan referred to in the foregoing Order in Council
