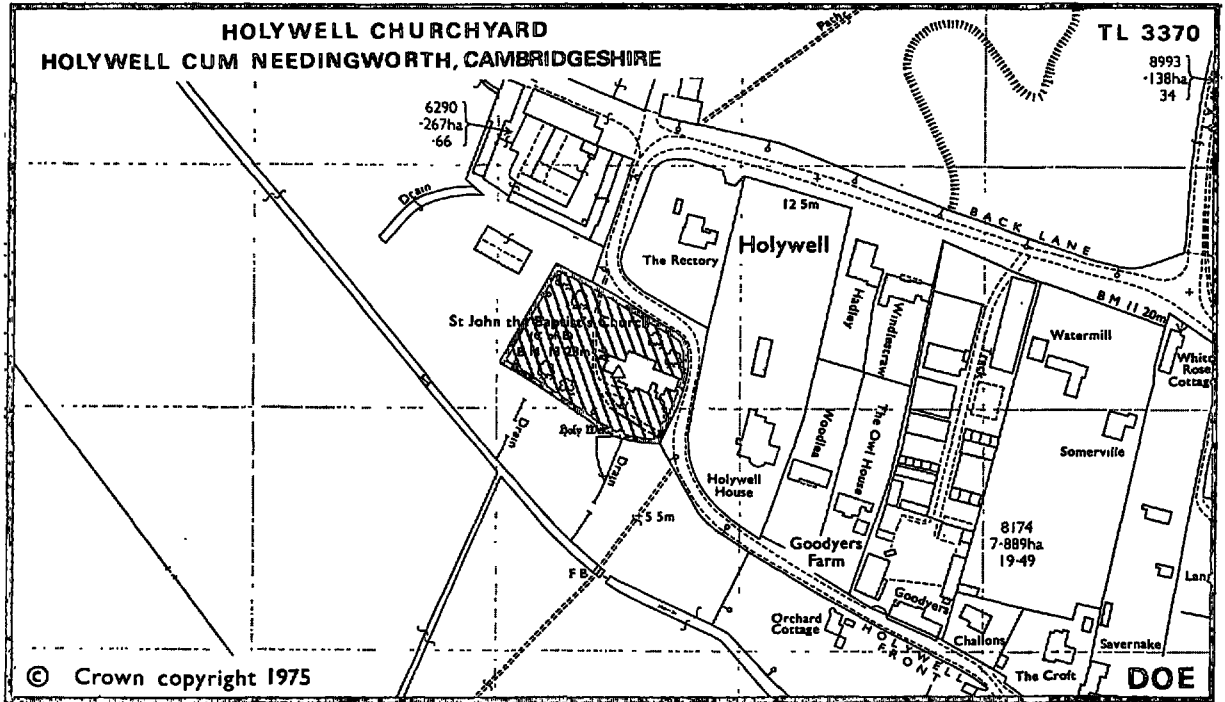
three feet below the level of the surface of the ground adjoining the grave.
