The Trunk Roads (Medway and Gillingham) (Restriction of Waiting of Vehicles of Over 2 Tons) Order, 197

The Secretary of State for the Environment proposes to make an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, and Schedule 6 to the Road Traffic Act, 1974, on the London-Canterbury-Dover Trunk Road (A.2.)

The effect of the Order would be to make permanent the provision in an existing experimental Order prohibiting any

provision in an existing experimental Order, prohibiting any mechanically-propelled vehicle, the unladen weight of which exceeds 2 tons, or any trailer which is drawn by a motor vehicle and exceeds 10 feet in length, from waiting in the following lengths of trunk road between 2100 hours and 0700 hours:

(a) that length of the London-Canterbury-Dover Trunk Road (A.2) which lies partly in the district of Medway and partly in the borough of Gillingham in the county of Kent and which extends from a point 250 feet west of the junctiton of Chatham Hill with Rock Avenue to a point 100 feet east of the junction of Moor Street with South Bush Lane; or (b) the Gillingham Link Road (A.278), known as Hoath Way, which lies in the borough of Gillingham in the county of Kent and extends from its junction with the A.2 Trunk Road to its junction with the M.2 Motorway.

Exceptions in the Order would enable a vehicle to wait long enough for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal
