(iii) the construction and improvement of highways and the provision of new means of access to premises in connection with the new trunk road in pursuance of the London-Penzance Trunk Road (Andover-Thrux-ton Section Side Roads) Order 197, the London-Penzance Trunk Road (Thruxton-Amesbury Section Side Roads) Order 197, the London-Penzance Trunk Road (Andover-Thruxton Section Side Roads) (No. 2) Order 197, and the London-Penzance Trunk Road Thruxton-Amesbury Section Side Roads) (No. 2) Order 197

(iv) the improvement of the London-Penzance Trunk Road in Bulford and Cholderton in the District of Salisbury in the County of Wiltshire and in Thruxton, Amport, Penton Grafton and Penton Mewsey in the District of Test Valley in the County of Hampshire;

(v) the diversion of watercourses and the execution of other works on watercourses in connection with the construction of the new trunk road, the construc-tion and improvement of other highways and the execution of other works mentioned above; and

(vi) use by the Secretary of State in connection with such construction and improvement of highways and such execution of other works as aforesaid;

(b) the land described in Schedule 2 to the Order for the purpose of mitigating any adverse effect which the existence or use of the highways proposed to be con-structed or improved by him as mentioned above will have on the surroundings thereof.
