The QUEEN has been graciously pleased to give and grant unto The Institute of Cost and Management Accountants Her Majesty's Royal Licence and Authority that it may bear and use certain Supporters which were granted and assigned unto The Institute of Cost and Works Accountants Limited by Letters Patent dated 17th January 1952, under the hand and seal of Garter Principal King of Arms, together with certain Armorial Bearings which were granted and assigned unto the said Letitute of Cost and Works and assigned unto the said Institute of Cost and Works Accountants Limited by Letters Patent dated 5th October 1932 under the hands and seals of Garter, Clarenceux and Norroy Kings of Arms: the said Armorial Ensigns being first duly exemplified according to the Laws of Arms and recorded in Her Majesty's College of Arms, otherwise the said Royal Licence and Permission to be void and of none effect.

And to command that the said Royal Concession and Declaration be recorded in the said College of Arms.

TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 19th March 1976, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act, 1968, to the amount of £400,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They
