# NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT 1952

To:-Mrs. E. MCKEE-NAUGHTON whose address unknown is outside the United Kingdom and whose Solicitors are: Kingsley, Napley & Co., 107-115 Long Acre, London, Kingsley, N WC2E 9PT.

Pursuant to section 275 (5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely one Fiat 132-1800 GLS motor car (Registration No. J 8462) has been seized as liable to forfeiture upon the grounds that:

- 1. the said goods being goods obtained outside the United Kingdom and in respect of which John Joseph Someo was not entitled to exemption from duty and tax were required by section 6 of the Finance Act 1968
- tax were required by section 6 of the Finance Act 1968
  to be declared by the said John Joseph Someo on entering the United Kingdom at Weymouth, Dorset, on 10th August 1975 and were not so declared;
  except as provided by or under the Customs and Excise Act 1952 the said goods, being imported goods chargeable with a duty of customs were without pay-ment of that duty unshipped at Weymouth, Dorset, on 10th August 1975 or removed from an approved wharf, examination station or transit shed by the said John Joseph Someo by driving the said goods in the Green Channel displaying a Green Sticker contrary to directions made by the Commissioners of Customs and Excise under section 6 (1) of the Finance Act 1968. Whereby and by force of section 6 (3) of the Finance Act 1968; and section 44 (a) of the Customs and Excise Act 1952, the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accord-ance with the said Schedule to the said Act specifying the name and address of a Solicitor in the United Kingdom who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceed-ings will be taken for the condemnetion thereof ings will be taken for the condemnation thereof.
