**MISUSE OF DRUGS ACT 1971**

**SECTION 12 (4)**

*Suspension of Direction Prohibiting Exercise of Powers in  
Relation to Controlled Drugs*

In accordance with section 12 (4) of the Misuse of Drugs Act 1971, notice is hereby given that on 13th April 1976, the Secretary of State gave the following direction which was served and thereby came into effect on 15th April 1976:

Whereas on 7th June 1973, a direction under section 12 (2) of the Misuse of Drugs Act 1971 was given in respect of Leonard William Robinson, M.B., Ch.B., a doctor, whose registered address is 30 Langholm Crescent, Darlington, County Durham, prohibiting him from having in his possession, prescribing, administering, manufacturing, compounding and supplying and from authorising the administration and supply of the substances and products for the time being specified in paragraphs 1 to 5 of Part I of Schedule 2 to that Act:

Now, in pursuance of section 12 (3) of that Act I, hereby suspend the said direction of 7th June 1973, insofar, and only insofar, as it was given in respect of the said Leonard William Robinson.

*The Trunk Road (Bow Street, Dyfed) (Restricted Roads)  
Order 1976*

Notice is hereby given that the Secretary of State for Wales intends to make an Order under sections 72, 73 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968. The effect of the proposed Order will be to extend the existing 30 m.p.h. speed limit on the Fishguard—Bangor Trunk Road (A487) at Bow Street in the County of Dyfed for a distance of about 100 yards in a north-easterly direction so that it will apply to the length of road specified in the Schedule to this notice.
