The Northampton Borough Council (Footpath KN 1)
Public Path Diversion Order 1976

Notice is hereby given that the above-named Order made on 27th April 1976 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed as an unopposed Order by the Northampton Borough Council.

The effect of the Order if confirmed without modification will be to divert part of the public right of way known as footpath KN 1 which runs from Hardingstone to London Road where it crosses the open field at Delapre. The right of way will be diverted around the northern side of the field, just inside the wood, and then down the western side of the field but still keeping to the eastern side of the existing fence.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at my offices during office hours.

The reasons for the proposed diversion are:

- for the efficient use of the land crossed by the footpath;
- 2. for the efficient use of land held with that land;
- 3. for providing a more commodious path.

Such a diversion would offer pedestrians both an acceptable and safe route bearing in mind the effect that the golf course will have uppon the existing footpath.

Any representation or objection with respect to the Order may be sent in writing to myself at the address below before 1st June 1976 and should state the grounds on which it is made.

If no representations or objections are duly made or if any so made are withdrawn the Northampton Borough Council may instead of submitting the Order to the Secretary of State for the Environment themselves confirm the Order. If the Order is submitted to the Secretary of State for the Environment any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.—Dated 27th April 1976.
