CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT 1952

Date 13th May 1976.

Pursuant to section 275 (5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the Customs and Excise Acts and enactments amending those Acts, certain goods, namely

2 cartons containing 400 Piccadilly King size filter cigarettes

have been seized as liable to forfeiture upon the grounds that on the 10th December 1975 at Gatwick Airport the said goods, having been shipped as stores on aircraft number D1CCC for use on a flight to the eventual destination of Frankfurt, West Germany, were without the authority of the proper officer unloaded at Gatwick airport, and at the time of the aforesaid unloading you were the commander of the said aircraft.

Whereby and by force of section 50 (3) of the Customs and Excise Act 1952, the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a Solicitor in the United Kingdom who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the

Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
