If you wish to question the validity of the Order or of any provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from the date of publication of this notice apply to the High Court for this purpose.

NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT, 1971—SECTION 210

*Braintree District Council (Part of Footpath No. 61,  
Braintree Public Path Diversion Order, 1976*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 14th May 1976, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Braintree District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way running from the east side of Springwood Drive at a point approximately 500 yards north of its junction with Rayne Road, Braintree, continuing in an easterly direction for 90 yards, a northerly direction for 45 yards and an easterly direction for 20 yards to a line running from the east side of Springwood Drive at a point approximately 490 yards south of its junction with Rayne Road continuing in an easterly direction for 102 yards and then in a northerly direction for 71 yards where it rejoins the existing route of Footpath No. 61.

A copy of the Order and the map contained in it has been deposited at the offices of the Secretary of the Braintree District Council, 18 Fairfield Road, Braintree, Essex, and may be inspected free of charge at that office between the hours of 9 a.m. and 5 p.m., Mondays to Fridays.

Any representation or objection with respect to the Order may be sent in writing to the Secretary of the Braintree District Council at 18 Fairfield Road, Braintree, Essex, not later than 21st June 1976, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Braintree District Council may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.
