Notice is hereby given that the Thurrock Borough Council in exercise of the power conferred on them by Section 11 of the above-mentioned Act on 7th June 1976 made Orders entitled the "Thurrock Borough Council No. 13 Smoke Control Order 1976" and the "Thurrock Borough Council No. 14 Smoke Control Order 1976" declaring the areas described in the schedules hereto and more particularly coloured pink on the maps forming parts of the Orders to be smoke control areas, which Orders are about to be submitted to the Secretary of State for the Department of the Environment for confirmation.

If on any day after the Orders have come into operation smoke is emitted from a chimney or any building within the smoke control areas the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20, unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Orders will not come into operation before 1st September 1977.

Copies of the Orders (and of the maps referred to therein) may be inspected free of charge at the Council Offices, Whitehall Lane, Grays at all reasonable times from 21st June 1976 to 21st August 1976.
