The Trunk Roads (Various Roads, Aberystwyth) (Prohibition and Restriction of Waiting) Order 1976

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974 the effect of which will be:

(a) to prohibit the waiting, loading and unloading of any vehicle on either of the sides of road specified in Schedule 1 to this notice;

(b) to prohibit the waiting of any vehicle in any of the lengths of road or on any of the sides of road specified

in Schedule 2 to this notice;
(c) to restrict the waiting of vehicles between the hours of 8 a.m. and 6 p.m. on any day other than a Sunday to 1 hour in any period of 2 hours on any of the sides of road specified in Schedule 3 to this notice.

The proposals insofar as they relate to Alexandra Road and Thespian Street are subject to the Secretary of State's decision on his proposals to trunk these roads.

Exceptions will be provided in the Order in relation to (b) and (c) above (1) to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; (2) to enable goods to be loaded on to or unloaded from the vehicle; (3) to enable the vehicle to be used in connection with any building, industrial or demolition operation; (4) the removal of any obstruction to traffic, the maintenance of the road or the services therein; (5) to enable the vehicle to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties; or (6) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said lengths or any of the said sides of road. In addition to the exceptions referred to in (3), (4) and (5) above, exceptions will be provided in to in (3), (4) and (5) above, exceptions will be provided in the Order in relation to (a) above, to enable vehicles being used for the purpose of delivering or collecting postal packets to wait on the sides of road referred to therein.

Exceptions will also be provided in the Order to allow:

- (i) vehicles bearing both a disabled person's badge and a parking disc to wait for a period not exceeding 2 hours (not being a period of waiting separated by an interval of less than I hour from a previous period of waiting by the same vehicle in the same length or on the same side of road) in any of the lengths of road or on any of the sides of road specified in Schedule 2 to this notice
- (ii) vehicles bearing a disabled person's badge to wait for as long as may be necessary on any of the sides of road specified in Schedule 3 to this notice.
