The Chesterfield Borough Council (Footpath No. 61) Public Path Diversion Order 1976

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 26th July 1976 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Chesterfield Borough Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert Public Footpath No. 61 running from its junction with Brockwell Lane in a south-westerly direction for a distance of 227 metres to a line running in a westerly direction for a distance of 97 metres then in a southerly direction following the new estate road to be constructed for a distance of 91 metres and finally in a westerly direction for a distance of 94 metres to the point where it rejoins the existing public footpath No. 61. At the widest point of the diversion the diverted path will be 42 metres to the south of the existing public footpath.
