*Notice of Application for an Emergency Order relating to a reduction in the residual flow in the River Taw below the Taw Marsh source*

Whereas, in view of an exceptional shortage of rain, a serious deficiency of supplies of water is threatened in the area of the South West Water Authority which is served from the Taw Marsh source in the Parishes of Lydford, South Tawton and Belstone in the West Devon District.

Notice is therefore given that in order to maintain an adequate supply of water the Authority is applying to the Secretary of State for the Environment for an Order pursuant to Section 1 (1) of the Water Act 1958 to enable it, for the period of the present emergency and for a period, in any case, not exceeding 6 months, to modify the conditions relating to the abstraction of water from wells and boreholes at National Grid references SX618905, SX616905, SX615906, SX619908, SX620909, SX619911, SX619912, SX620912 and SX619915 as contained in Licence of Right to Abstract Water No. 14/50/08/0563/07 and 08/94 so as to provide that the residual flow in the River Taw below the Taw Marsh source shall be reduced from 4.55 T.C.M. (1.0 m.g.d.) in any period of twenty-four hours to 1.14 T.C.M. (0.25 m.g.d.) in any period of twenty-four hours.

(Amendment) Order 1976*

  - Excess charges—To be "£1"
  - Goods Vehicles exceeding 1 ton Unladen Weight—To be "50p" per visit
  - Coaches: Parking—To be "50p" per visit; Picking up and Setting down—To be "10p"; Plying for hire—To be "20p"
  - NOTE: No change is proposed in the charge for motor cycles.
- (e) To permit certain temporary surface level Group II car parks to be operated on a fixed charge of 10p per visit on such days as the Council may from time to time determine.

(c) (*Old Green Interchange and Various Roads (Parts) (Prohibition of Waiting) Order 1976*—

(i) Vehicles may not wait at any time on parts of Lyne Road, Evans Street, Shaftesbury Street Service Road, Wyndham Street, bus bays, Corn Street and Skinner Street in Newport.

(ii) Exceptions have been included in the Order to permit waiting for the purposes of—

- (a) picking up and setting down passengers;
- (b) loading and unloading goods;
- (c) delivery or collection of postal packets;
- (d) the maintenance of the roads;
- (e) fire brigade, police or ambulance services;
- (f) the supply of gas, water, electricity and of any telegraphic line;
- (g) in pursuance of statutory powers or duties;
- (h) exempting disabled persons; and
- (i) a funeral.

(d) (*Old Green Interchange (Clearway) Order 1976*

(i) Vehicles may not wait at any time on the roads forming the Old Green Interchange from Evans Street Roundabout to Llanarth Street in Newport.

(ii) Exceptions will be included in the Order to permit waiting for the purposes of or in connection with—

- (a) building, industrial or demolition operations;
- (b) removal of obstructions to traffic;
- (c) the maintenance of the road;
- (d) the supply of water, gas or electricity and of any telegraphic line;
- (e) fire brigade, police or ambulance services;
- (f) in pursuance of statutory powers or duties;
- (g) delivery and collection of postal packets; and
- (h) omnibuses waiting at a bus stop in a lay-by.

The Orders and maps showing the affected roads may be examined at my Office between 8.30 a.m. and 4.30 p.m. Mondays to Fridays.
