ROAD TRAFFIC REGULATION ACT 1976; TRANSPORT ACT 1968; LOCAL GOVERNMENT ACT 1972

The Northampton Borough Council (Marlborough Road|St. James Park Road) (Prohibition of Waiting) Order 1976

Notice is hereby given that the Northampton Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Northamptonshire County Council in exercise of the powers of the said County Council under section 1 of the Road Traffic Regulation Act 1967, as amended, intend to make an Order the effect of which will be to prohibit waiting at any time on the lengths of road contained in the Schedule.

Marlborough Road	South-East	(i) From a point 30 metres north-east of the junction with St. James Road for a distance of 110 metres north eastwards; (ii) From the junction with St. James Park Road for a distance of 10 metres westwards.	
	North-West	From a point 103 metres north-east of the junction with St. James Road to the junction with St. James Park Road.	
St. James Park Road	North-East	From a point 134 metres from the south-east end for a distance of 93 metres north-west including 7 metres of access road to No. 55 St. James Park Road.	
	South-West	(i) From a point 20 metres south-east of the junction with Marlborough Road for a distance of 18 metres south eastwards; (ii) From a point 6 metres north-west of the junction with Marlborough Road to a point 7 metres south-east of that junction.

RUSHMOOR BOROUGH COUNCIL

The Rushmoor Borough Council (Off-Street) Parking Places (Amendment) (No. 1) Order 1976

Notice is hereby given that the Rushmoor Borough Council, with the consent of the County Council of Hampshire, on 2nd August 1976, made an Order under section 31(1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 the effect of which is to amend the Borough of Rushmoor (Off-Street Parking Places) Order 1975 (the 1975 Order) by varying certain of the charges made for the use of the parking places mentioned in the Schedule to this Notice which shows the class of vehicles, the days and times of operation, the maximum waiting times and the scale of charges proposed for the parking places.

The Order specifies the conditions under which the parking places may be used by reference to the 1975 Order. Full details are contained in the Order which, together with a copy of the 1975 Order, and a map showing the location of the parking places, may be seen at the Town Hall, Farnborough and the Town Hall, Aldershot, during normal office hours.

The Order will come into operation on 9th August 1976.
