*The London-Fishguard Trunk Road (Pound Hill and Coedkernew Lay-Bys) (Restriction of Waiting) Order 1974.*

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit waiting in the lay-bys specified in the Schedule to this notice:

- (a) for a longer period than 4 hours, or
- (b) if a period of less than one hour has elapsed since the termination of the last period of waiting (if any) of a vehicle in the lay-bys.

This Order will replace the London-Fishguard Trunk Road (Pound Hill and Coedkernew Lay-bys) (Restriction of Waiting) (Experimental) Order 1974.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

Exceptions have also been provided in the Order for a disabled person's vehicle which displays in the relevant position a disabled person's badge, to wait in either of the lay-bys specified in the Schedule to this notice.

A copy of the proposed Order, together with a plan and a statement of reasons for making the Order, may be seen during normal office hours at the offices of the Gwent County Council, County Hall, Cwmbran, Gwent.
