GRAVESHAM BOROUGH COUNCIL

The Gravesham Borough Council (Various Streets) (Prohibition and Restriction of Waiting) (Nos. 1, 2 and 3) (Variation) Orders 1976.

Notice is hereby given that on the 27th July 1976 the Gravesham Borough Council as agent of the Kent County Council made the above-named Orders under section 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972.

2. These Orders which

- (a) amend the Borough of Gravesend (Various Streets) Prohibition and Restriction of Waiting (Consolidation) Order 1973 so as to:

(i) Include reference to the Kent County Council, the Gravesham Borough Council and section 84D of the Road Traffic Regulation Act 1967, in the preamble to the Order;

(ii) Delete reference to the special exemption for vehicles taking in petrol, oil, water or air at garages in Pelham Road South and Wrotham Road and to substitute therefore a general exemption for such vehicles;

(iii) Bring up to date the wording of the exemption relating to invalid carriages and disabled persons vehicles;

(iv) Extend the prohibition and restriction of waiting in Clarence Place and in the un-named road between Clarence Place and Sandy Bank Road;

(v) Impose prohibition of waiting at any time in St. James's Street at its junction with St. James's Road;

(vi) Impose prohibition of waiting at any time in Barrack Row and Anglesea Place;

(vii) Extend prohibition of waiting at any time in Clive Road.

- (b) amend the Urban District of Northfleet (Various Streets) (Prohibition and Restriction of Waiting) Order 1968 so as to

(i) Amend the preamble and reference to disabled persons vehicles as mentioned in 2 (a) (i) and (ii) above;

(ii) Extend the prohibition of waiting in London Road west of Fountain Walk and between Beresford Road and Burnaby Road;

(iii) Extend the restriction of waiting 8 a.m. to 7 p.m. on the west side of Springhead Road between a point opposite No. 41 and the railway bridge.

- (c) amend the Urban District of Northfleet (Various Streets) (Prohibition and Restriction of Waiting) Order 1973 so as to:

(i) Amend the preamble and reference to disabled persons vehicles as mentioned in 2 (a) (i) and (ii) above;

(ii) Extend the prohibition of waiting on the west side of Burch Road north of Chestnut Close and to impose prohibition of waiting in Chestnut Close.

will come into force on the 9th August 1976.
