HALTON BOROUGH COUNCIL

The Halton Borough Council (Cooper Street and Midland Street, Widnes) (Prohibition of Loading and Unloading) Order, 1976

Notice is hereby given that the Halton Borough Council, as Agents for the Cheshire County Council, propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be to prohibit the waiting of vehicles in the lengths specified in column 2 of the Schedule to this Notice of the roads specified in column 1 of the Schedule on such days and during such hours as specified in column 3 of the Schedule, respectively, for the purpose of enabling goods to be loaded onto or unloaded from a vehicle.

The Order would contain exemptions for the delivery and collection of postal packets and for vehicles to be used in pursuance of statutory powers or duties.

A copy of the proposed Order and a map showing the roads to which it relates together with a Statement of the Council's reasons for proposing to make the Order may be inspected during normal office hours at the Municipal Building, Kingsway, Widnes. Objections to the proposal together with the grounds on which they are made must be sent in writing to the undersigned by 30th August 1976.

HALTON BOROUGH COUNCIL

The Halton Borough Council (Hale Road|Ditchfield Road|St. Michaels Road) (Revocation and Prohibition of Waiting) Order 1976

Notice is hereby given that the Halton Borough Council, as Agents for the Cheshire County Council, propose to make an Order under sections 1 and 84D(1) of the Road Traffic Regulation Act 1967, as amended, the effect of which would be:

- (1) to revoke the Order specified in column 1 to the extents specified respectively in column 2 of Schedule 1 to this notice;
- (2) to prohibit, with certain exceptions, the waiting of vehicles in the lengths specified in column 2 of the roads specified in column 1 of Schedule 2 to this notice.

The Order would contain exemptions to permit waiting for the purposes of boarding or alighting, loading or unloading, maintenance of essential services, building and roadworks, the delivery or collection of postal packets and for disabled persons to park their vehicles.

A copy of the proposed Order and a map showing the lengths of roads to which it relates together with a statement of the Council's reasons for proposing to make the Order may be inspected during normal office hours at the Municipal Building, Kingsway, Widnes. Objections to the proposed Order together with the grounds on which they are made must be sent in writing to the undersigned by 30th August 1976.
