

Drive and northwards along the rear boundaries of Nos. 3 to 27 Carisbrooke Drive; continuing northwards along the eastern boundary of No. 22 Esher Grove to Esher Grove; thence eastwards and northwards along the centre line of Esher Grove to Mapperley Hall Drive.

The boundary then turns westwards along the centre line of Mapperley Hall Drive to Mansfield Road; thence northwards along the centre line of Mansfield Road to Mapperley Street; thence in an easterly direction along the centre line of Mapperley Street and extending along the rear boundaries of Nos. 37 to 47 Private Road; thence southwards along the eastern boundary of No. 47 Private Road and east and south-east along the centre line of Private Road to a point opposite the north-western boundary of No. 431 Woodborough Road and southwards along this boundary and continuing along the south-western boundary of No. 72 Private Road and then north-westwards along the rear boundaries of Nos. 72 to 64 Private Road to the eastern boundary of No. 18 Victoria Crescent.

The boundary then turns south-west along the south-eastern boundary of Nos. 18 and 16 Victoria Crescent and thence south-east along the rear boundaries of Nos. 27 to 31 and "High Garth", Richmond Drive to a point on the rear boundary of No. 17 St. Jude's Avenue; thence south-west along the south-eastern boundary of "High Garth", Richmond Road and turning south-east along the centre line of Lucknow Drive to Woodborough Road.

The boundary then turns south-west along the centre line of Woodborough Road to a point opposite the northern boundary of "Trent House", The Crescent, Alexandra Park; thence eastwards along this boundary and the centre line of The Crescent to a point opposite the eastern boundary of No. 24 The Crescent; then southwards along this Crescent; thence in a generally south-westerly direction following the south-eastern boundary of No. 14 The Crescent and the north-western boundary of the open space to the rear of "Springfield" Children's Home, The Crescent to the eastern boundary of "Enderleigh", The Crescent; thence south and west along the boundaries of "Enderleigh", The Crescent and "Alexandra Court", Woodborough Road; thence crossing Woodborough Road and turning south-westwards along the centre line of Mapperley Road to the point of commencement.

Richmondshire District Council Public Footpath Diversion Order No. 1 (Middleham) 1976

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 19th July 1976, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Richmondshire District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way described in Part I of the Schedule hereto to the alternative route described in Part II of the Schedule.

A copy of the Order and map contained in it has been deposited at the Council Offices, Thornborough Hall, Leyburn, North Yorkshire, and may be inspected, free of charge, at such offices on Mondays to Fridays in any week between the hours of 8.45 a.m. and 4.45 p.m.

Any representation or objection with respect to the Order may be sent in writing to the Chief Executive, Richmondshire District Council, Council Offices, Swale House, Frenchgate, Richmond, North Yorkshire, DL10 4JE, not later than 6th September 1976, and should state the grounds on which it is made.

If no representations or objections are duly made or if any so made are withdrawn, the Richmondshire District Council may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order.

If the Order is submitted to the Secretary of State for confirmation, any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

(Description of site of existing Path or Way)

(Description and site of alternative Highway)

A six feet wide footpath commencing at Grid Reference 124879 on Ordnance Survey Sheet No. 6815 (1913 Edition) more particularly shown marked "A" on the plan annexed to the Order, for a distance of 180 feet to a point marked "B" lying 130 feet in a north-westerly direction from point "A" on the said plan via points C, D and E marked on the said plan.

ROTHERHAM BOROUGH COUNCIL

TOWN AND COUNTRY PLANNING ACTS 1971-74

Designation of Conservation Areas at Gildingwells, Harthill, Ravenfield and Wales

Notice is hereby given that the Rotherham Borough Council in pursuance of their powers under section 277 of the Town and Country Planning Act 1971 (as amended by the Town and Country Amenities Act 1974) have designated the areas described in the Schedule below as Conservation Areas, being areas of special architectural or historic interest, the character of which it is desirable to preserve and/or enhance.

The effect of the designation is that, with certain exceptions buildings within the Conservation Areas may not be demolished without the consent of the Local Planning Authority. In addition, with certain exceptions, it is an offence to lop, top, fell, uproot, wilfully damage or wilfully destroy a tree within a Conservation Area without the consent of the Local Planning Authority.

Copies of plans showing the exact boundaries of the Conservation Areas have been deposited at the Department of Legal and Administrative Services, Civic Building, Frederick Street, Rotherham, and may be inspected without charge during normal office hours from Monday to Friday inclusive.

SCHEDULE

Gildingwells

The area includes all properties on Burrs Lane and Woodsetts Road. An envelope of agricultural land to the east and west of Burrs Lane and to a depth of approximately 700 feet has been included.

Harthill

The area includes properties on Union Street from Nos. 2-112 and Glebe Farm to No. 85; 1-9 Thorpe Road; properties on Serlby Lane from its junction with Union Street to Nos. 23 and 28; Nos. 1-3, 2-4 South Farm Avenue, 1 and 2 Doctor Lane; 1-3 Winney Hill; properties on Woodall Lane from its junction with Union Street to include the surgery and the Methodist Church; and all properties on Dishwell Lane, Jackys Lane and Chapel Yard.

Ravenfield

The area includes all properties on Main Street, Bosville Close, Church Lane and Church Close; 15 and 17 St. James' Drive; Nos. 1-4 Fairfield, Hall Farm and Hall Farm Cottage on Hooton Lane; and approximately 26 acres of Ravenfield Park which includes the Parish Church of St. James.

Wales

The area includes properties on Manor Road from Brooklands Farm and the Old Smithy south to its junction
