#### HONOURS AND AWARDS

The Queen has been graciously pleased, on the advice Her Majesty's Australian Ministers, to approve the award of the Queen's Gallantry Medal to the undermentioned:

Sergeant Second Class Selwyn Ronald Bick, Queensland Police Force.

At 7.20 a.m. on 12th October 1974, police were called to a property at Felton East, near Cambooya, Queensland, where a man carrying a '22 rifle was attempting to abduct a young girl.

Sergeant 2/c Bick, one of the three members of the Queensland Police Force who answered the call, unhesitatingly approached the man, took the rifle from him and, after a struggle, freed the girl, overpowered the man and arrested him.

Sergeant Bick displayed a very high sense of duty without regard for his own safety.

Douglas Frederick CAMPBELL.

On the afternoon of 21st March 1975, Douglas Frederick Campbell was informed that a man was running down Currie Street, Nambour, Queensland, firing a revolver. Campbell ran down the street, confronted the armed man and successfully disarmed him of the revolver and a handsaw with which the offender had attacked him. The man had, immediately prior to these events, shot and killed a person in Currie Street and fired other shots at random. The intervention by Douglas Frederick Campbell without regard for his own safety displayed outstanding bravery.
