TYNE AND WEAR COUNTY COUNCIL

Tyne and Wear County Council (Rutherford Street, Newcastle upon Tyne) Restriction of Waiting Order 1976

Notice is hereby given that Tyne and Wear County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Order will be to prohibit waiting between the hours of 6.30 p.m. and 8 a.m. on all days, on the east side of Rutherford Street, Newcastle upon Tyne, from its junction with Westgate Road to its junction with Bath Lane, and the combined effect with the meter zone restrictions will be to prohibit waiting at any time.

Exceptions would permit waiting for the purposes of:

- (a) picking up or setting down passengers,
 - (b) goods to be loaded onto or unloaded from the vehicle,
- and, where necessary, in connection with:
- (c) the maintenance of the roads, and
 - (d) the supply of gas, water or electricity.

TYNE AND WEAR COUNTY COUNCIL

Tyne and Wear County Council (Part of Ellison Place) (No. 3) Newcastle upon Tyne Parking Places and Restriction of Waiting (Variation) Order 1976.

TYNE AND WEAR COUNTY COUNCIL

Tyne and Wear County Council (Unnamed Access Road North of Archbold Terrace) Newcastle upon Tyne Parking Places and Restriction of Waiting (Variation) Order, 1976.
